PRESENTATION – UNI Dome renovation funding request; Dr. Mark Nook, University of Northern Iowa President; David Harris, UNI Director of Athletics; Jamar Thompson, UNI Associate Athletic Director. The trio said that the renovation is part of a \$250 million project to build the UNI that tomorrow needs. The Dome will be 50 years old in 2024 and brings \$17 million a year into the community. They described the proposed changes, which have a goal of \$50 million, and asked the county to consider donating \$5 million. Hall asked if the City of Cedar Falls had been similarly approached. Harris said it had, and the city has pledged two annual donations of \$1.25 million each. Former County Treasurer Rita Schmidt said her office and her relatives held a small fundraiser for the project and encouraged other offices to do the same.

RECEIVE PROJECT UPDATES FROM DEPARTMENT HEADS/ELECTED OFFICIALS. County Engineer Cathy Nicholas said gravel roads are in poor condition but will hopefully dry up enough soon to place spot rock on them. Human Resources Director Amanda Fesenmeyer said that departments have been filing their employee-completed position description questionnaires with her office, and that the department-head approved questionnaires are due March 3. Conservation Director Mike Hendrickson said the maple syrup festival at Hartman Reserve will be March 10-12, and that reservations are filling up.

Moved by Hall, seconded by Schwartz that the MINUTES of the Board Meeting held February 21, 2023 be and are hereby approved as submitted. Motion carried.

Cedar Wapsi Road Bridge over Crane Creek, be approved and direct the Chair to sign for same as recommended by Catherine Nicholas, County Engineer.

Nicholas said the project is estimated to cost \$700,000.

NAYS: None. Resolution adopted.

Hall moved the following resolution seconded by Schwartz.

BE IT HEREBY RESOLVED that the Preconstruction Agreement between Black Hawk County, Iowa, and the Iowa Department of Transportation for Project No. NHSX-063-5(72)—3H-86 for the paving of gravel road approaches along US 63, at an estimated cost of \$52,500 to Black Hawk County, which is budgeted for FY2023, be approved and direct the Chair to sign for same as recommended by Catherine Nicholas, County Engineer.

Nicholas said that the project was approved for the last construction season and funds are currently budgeted.

AYES: Hall, Little, Schwartz, Trelka, Laylin.

NAYS: None. Resolution adopted.

Hall moved the following resolution seconded by Trelka.

BE IT HEREBY RESOLVED to approve the Treasurer's Office Remodel Project with an estimated cost of \$500,000, to be paid for with American Rescue Plan funds.

Assistant County Attorney and ARPA Committee Chair Mike Treinen said the amount is a rough estimate and if the project goes over \$1 million a written justification will be required. He said the question was asked as to whether keeping ARP funding under \$1 million for a project funded from multiple sources would avoid the need for a written justification, and he said it would. Little asked for the advantages of that. Treinen said that experience has shown that written justifications make projects take longer and cost more, since architects must be consulted and ARP consultants devote more time and resources to the project. Schwartz said he supports this project as well as the Election Office relocation and especially a new public health clinic.

AYES: Hall, Little, Schwartz, Trelka, Laylin.

NAYS: None. Resolution adopted.

Discussion – parking in courthouse lot. Maintenance Supervisor Rory Geving said the county ordinance on county parking lots has criteria for temporary permits but not for permanent ones. The current unwritten policy is that permanent permits are reserved for county vehicles, employee vehicles used for county business on a regular basis, and the vehicles of elected officials, department heads, judges and magistrates and the news media. Plus, a number of vehicles were grandfathered in from past use. There are 154 stalls, and there are 92 permanent permits, 62 for frequent users and 30 for occasional users. Geving said that the ordinance needs language for permanent permits to be effective. Little said that the main purpose of the ordinance is to set a fine for violations (public use is limited to 30 minutes) but changeable criteria for permits shouldn't be in the ordinance. Schwartz said the criteria should go into the ordinance without grandfathering. Laylin said she would like to see some policy changes tried and possibly amended. County Auditor Grant Veeder said the discussion had been initiated after a request from his office to grant a permit to an individual who often works before and after regular hours, so that walking in the dark to remote parking is a safety issue. Laylin asked that a new set of criteria be brought back for discussion.

Moved by Little, seconded by Schwartz that the PERSONNEL REQUISITION for the Financial Specialist, (full time) in the Treasurer's Office be approved, as recommended by Lynda Hintzman, Treasurer. Motion carried.

Moved by Hall, seconded by Schwartz that the TRAVEL REQUEST submitted by Amanda Fesenmeyer, Human Resources Director, be approved and direct the Chair to sign for same: to attend the National Public Employer Labor Relations Association (NPELRA) annual conference in Louisville, KY, scheduled for April 23-26, 2023, for an estimated cost of \$2,373.00. Motion carried.

DISCUSSION/POSSIBLE BOARD ACTION – Consideration of all aspects of the FY24 Black Hawk County Budget. Finance Director Michelle Weidner wished to set the maximum levy hearing for March 14 and the final budget hearing for March 28. She reviewed decisions made by the supervisors on February 21 and explained the effects of several adjustments she recommended that would lower tax askings, including greater use of the Sheriff's Commissary Fund, the 60-40 Jail Room and Board Fund, the Attorney's Fines Fund, and American Rescue Plan funds, and a necessary reduction of Secondary Road transfers from the Basic and Rural Funds occasioned by the state's lowering of the county's taxable valuation. She also recommended that the Rural Fund transfer to the Secondary Roads fund be reduced from 100% of the maximum to 95%, since Local Option Sales Tax Fund monies are now being directly deposited in the Secondary Roads Fund instead of being used for servicing secondary roads project debt.

Trelka moved the following resolution seconded by Schwartz.

BE IT HEREBY RESOLVED to change the Rural Basic Fund transfer to the Secondary Roads Fund for FY24 from 100% of the maximum to 95% of the maximum.

AYES: Hall, Little, Schwartz, Trelka, Laylin.

NAYS: None. Resolution adopted.

Weidner said budgeted revenue from investments will increase by about \$1 million due to higher interest rates and larger reserves. She reviewed increases and decreases in revenue and expenditure throughout the budget and said the net effect in tax askings would be a decrease of 0.9%. She cautioned that some factors would not recur in FY25 so a substantial increase could be anticipated then. She reviewed the 60-40 Jail Room and Board Fund and said that projected increases in expenditures are likely to outstrip revenues in FY25 if revenues remain at current levels. She said in its current state, the FY24 budget would mean the following increases for properties valued at \$100,000: Residential, \$1.79. Rural Residential, \$10.73. Commercial and Industrial, decrease of \$1.87. Agricultural, \$33.85. Multi-residential, decrease of \$52.40.

Weidner moved on to requests for changes in staffing. Schwartz said he agreed with the changes presented and that since they were all included in the current iteration of the budget that showed a \$1.79 increase on a \$100,000 house he thought they should be approved. He said such a small increase wouldn't hurt people on the margins, but a lack of services would. Little said that some positions are tied to grants that are not perpetual. HR Director Fesenmeyer said that grants are fluid, especially in the Health Department, and some positions are only partially covered by grants, and that in some cases decisions will have to be made about whether to continue a position after all or part of the funding runs out.

Schwartz said that the full-time Naturalist 1 requested by Conservation would expand the quality and quantity of programing at Hartman Nature Reserve, which is part of the quality-of-life investment that grows population and tax valuation. Schwartz moved the following resolution seconded by Hall.

BE IT HEREBY RESOLVED to approve the request by Conservation for one full-time Naturalist 1 (\$78,123) and to increase seasonal pay (\$11,434) in FY24.

AYES: Hall, Schwartz, Laylin.

NAYS: Little.

ABSENT: Trelka. Resolut

Resolution adopted.

Schwartz moved the following resolution seconded by Hall.

BE IT HEREBY RESOLVED to approve the request by the County Attorney to add one full-time Victim Witness Coordinator (\$85,595) and to remove a 0.5 FTE Investigator (\$28,719) and a 0.5 FTE Discovery Compliance Officer (\$45,621) for a net increase of \$11,255.

AYES: Hall, Schwartz, Laylin.

NAYS: None.

ABSENT: Little, Trelka. Resolution adopted.

In the apparent absence of Supervisors Little and Trelka (who had been attending via Zoom) Laylin and Weidner suggested waiting until Thursday March 2 to continue. Schwartz and Hall wished to continue.

Schwartz moved the following resolution seconded by Hall.

BE IT HEREBY RESOLVED to approve the full-time Marketing Coordinator (\$106,528) in the Board of Supervisors office. Laylin said she would oppose the motion and she hoped they wouldn't have to repeat any actions when the full board is present. Hall suggested a recess to try to locate Little and Trelka.

Laylin called for a recess.

Following the recess, Little and Trelka were still absent. Assistant County Attorney Treinen said that the law requires some resolutions to be passed by a majority of the Board and not just a majority of those present, but he didn't think this applied to the resolution under consideration.

AYES: Hall, Schwartz. NAYS: Laylin.

ABSENT: Little, Trelka. Resolution adopted.

The Board decided to wait until March 2 to consider further action.

On motion and vote the meeting adjourned.
