RECEIVE PROJECT UPDATES FROM DEPARTMENT HEADS/ELECTED OFFICIALS. County Engineer Cathy Nicholas said that the Iowa legislature has sent to the governor a bill that allows ATVs and UTVs on all Iowa roads in certain circumstances.

Veterans Affairs Director Yolando Loveless described the activities of his office during May. He said they served 183 vets, 33 of them for the first time, and 11 of the 33 from other counties. He said the Memorial Day parade was a big success. He thanked those who placed flags in cemeteries, and he mourned the loss of another veteran by suicide over the weekend.

Human Resources Director Amanda Fesenmeyer said this was the final day of open enrollment for county employees to make changes in benefits. She said the county is experiencing more vacancies than usual and that exit interviews indicate that a lot of people are looking for remote or more flexible work schedules. She is gathering information on possible utilization of those tools at the county. Trelka asked about resignation trends. She said the county has averaged 50-54 resignations per year in the last five years, but there are already 30 so far this year.

DISCUSSION/POSSIBLE BOARD ACTION – ARPA Committee recommendation for consultant. Finance Director James Perry said the committee still recommends Baker Tilley (see minutes of May 24). Laylin said that information provided by the committee shows that some other counties are using staff internally and others are hiring consultants and asked if any of the counties had engaged Baker Tilley. Perry said that Scott County employs them as their independent auditors and is very satisfied with their performance. Trelka and White said that this would be an important insurance policy for the county. Schwartz agreed and said the county will benefit from Baker Tilley's experience with ARPA projects.

Trelka moved the following resolution seconded by Schwartz.

BE IT HEREBY RESOLVED to accept the recommendation of the American Rescue Plan Act (ARPA) Committee to engage Baker Tilley for purposes of consultation in the matter of county projects using ARPA funds.

Little asked if the supervisors would see the contract before the June 7 meeting, when it will be on the agenda for approval. Assistant County Attorney Mike Treinen said that the contract will be in the form sent to the supervisors last week except that he is asking Baker Tilley to change two provisions regarding insurance. Laylin asked if Baker Tilley staff will hold in-person meetings. Perry said meetings will probably be held virtually to save travel expenses. Little asked if projects already approved by the supervisors would go through an approval process with Baker Tilley. Perry said that they would be reviewed for the correct expenditure category, and if any are found to be categorized improperly, they can still be expensed in the \$10,000,000 "lost revenue" category.
